Mr. Foushee:

*I am forwarding to you an email I just sent to Andy Richards (SFO District Manager) and Ros Marable (AWP-16). Ros wrote the removal proposal and decision letters for my case, three years ago. Andy was the one FAA ATO manager most responsible for this removal, and most knowledgeable of the history, including some clearly unethical Agency actions. I am bringing these to your attention with the hope that you (or one of your staff) will be able to proactively investigate this case... perhaps, contact me so I can explain the case and provide the documentation, then contact Andy and others to get their side of the story. And, hopefully, just making these few inquiries will nudge WSA-ATO to voluntarily clean up a mess that never should have happened.*

*I will also be forwarding another email sent earlier today, to Mark Deplasco (with a few cc's to others involved in this case). I hope to hear back from Mark and/or the others soon, but intend to seek Congressional assistance in getting answers to those questions, if necessary.*

*For what it is worth, I believe deeply in the job your office is intended to do. It is an unfortunate reality of aging organizations like FAA, that missions become subordinated to smaller, self-serving agendas, which sometimes corrupt the larger organization. My case demonstrates one way in which FAA has failed...and it offers a clean opportunity for your office to serve.*

Andy and Ros,

Please confirm you received copies of the email sent this morning to Mark Deplasco.

Please also take a close look at the two attached emails. I sent these both to Andy on 8/14/08, and he forwarded them both to Ros early the next morning.

My removal case was fairly unique, so I am confident you both have some basic recollection of it. You will both recall, when I sent these two emails to Andy on 8/14/08, I had barely a week left before the 8/24 deadline to submit my rebuttal to the removal proposal which Ros had drafted, and Andy had signed. Thus, I very much needed at least one of you to provide some answers to the questions I presented...yet neither of you did. Of course, I also had no idea at the time that Ros had previously drafted a 14-day suspension proposal, and twice sent it to Andy for review...only to upgrade it to a removal **IN RETALIATION FOR MY FILING GRIEVANCE NC-08-79364**. Likewise, I had no idea that no Douglas Factors had yet been done, that AWP-16 had been telling WSA-ATO in biweekly reports I was AWOL - for EIGHT months! - no less, or that, back in December 2007, Andy wanted to reassign me to STS ATCT. Now that I do know these facts, I have even more questions for you...


...but maybe it would be easier if we just cleaned up those old questions and the wrongful Agency actions that necessitated the asking. We all know this was wrong, and is still wrong. So, can we clean this up?
