Cindy & I just returned a call and talked to Justin Lewis. It is always an "experience" talking to him. Among everything else, he did say some things that made sense and some that I have concerns about. First off - did AWP-300 notify Jeff "in writing" pursuant to the CBA (White Book), Article 66, Section 6c, that his medical was withdrawn and the reason for this? Lewis stated that he has called medical to discuss his "status" and is referred to me. I do not how true this is, but if it has to deal with medical certificate, etc., I am not in a position to address this; only medical can advise him on this. Justin also stated that his medical exam results were forwarded to AWP-300 around May 28 - do you have the report up there.

Doctors, fyi, I am working on developing a letter for Jason to propose Justin's removal for failure to provide the required medical documentation. If this has already been done, we may need to rethink our strategy.
