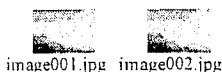

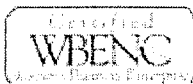

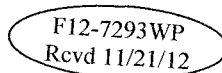

Realtime rates are in addition to, not in place of, any transcript fees. Any party receiving realtime services, either through connecting to the reporter's computer or in the form of a rough ASCII, will be billed for a transcript in addition to realtime fees.

Expedites

Normal delivery time is ten to fifteen business days. Delivery in less than ten business days is termed an "expedite" and increases the page rate in ratio to the speed of delivery.

Additional Charges

Parking is billed at actual cost.

Special Exhibit Copying: There are additional charges for copying items such as blueprints, x-rays, MRI films, audio or video tapes color photographs, glass work, Bates stamping, DVDS, exhibit handling, marking and sorting, etc.

Conference Rooms: There is no charge for use of conference rooms in any of our offices or other locations where we have arranged free use of conference facilities. In the event that a free conference room is not available in the city where the deposition is to take place, the room will be billed at cost plus \$25 administrative fee.

Special Facilities: Arrangements can be made for such items as video-playback equipment, etc. These items will be at cost. Video conference facilities are billed at cost plus \$25 per hour per location administrative fee.

Notes

1. The Page Rate of a deposition is determined by the type of witness rather than the type of case. For example, the deposition of the treating physician in a personal injury matter would be a medical deposition.
2. Processing and Handling includes such actions and costs as certification, handling of witness signature, notification of parties of witness changes, sealing and filing of original with court if necessary, archival, binders and tabs, and other miscellaneous items.
3. Videotaped Per-Page charges are in addition to the Videographer's fee.
4. Interpreted Per-Page charges are in addition to the Interpreter's fee.
5. Same-day Cancellations - An appearance fee will be charged for same-day cancellations made 2 hours or less from the start time.
6. Invoices are due upon receipt. After 30 days a service charge of .75% per month will be added.
7. Public hearings, meetings and conventions are \$3 on top of the medical expert page rate plus per diem. A minimum of \$750 applies.
8. These rates are for major metropolitan cities. A per diem of \$200 will apply to remote locations.

* Also covers Exam Under Oath and Statement Under Oath.
